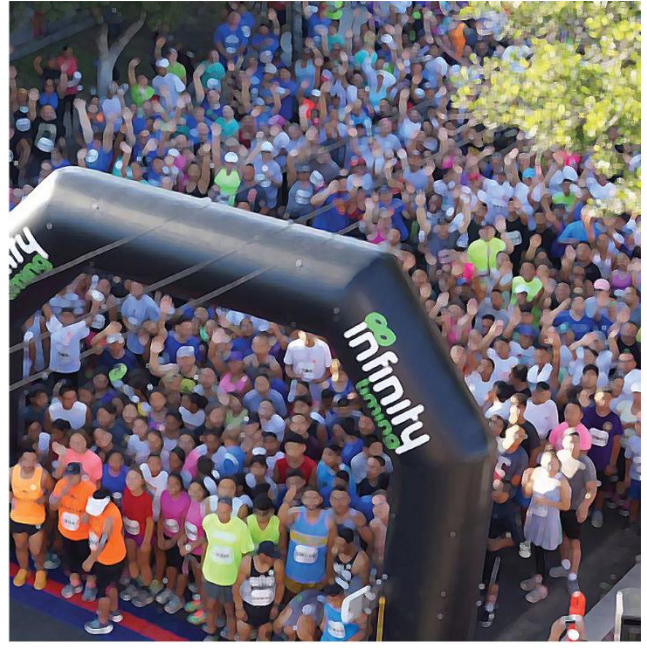

TOURNAMENT

The City of Santa Ana in collaboration with the Santa Ana Unified School District and Santa Ana Chamber of Commerce are committed to executing a prosperous National Forensics Association Tournament from April 18 – April 23, 2019. The three entities have a strong working relationship and are dedicated to making this tournament experience so amazing that NFA will want to come back year after year. The Santa Ana Unified School District (SAUSD) will provide more than enough facility space to



accommodate the needs and requirements of the National Forensics Association Tournament. SAUSD has hosted several local speech and debate tournaments at the following proposed sites, which have proven to be efficient and pleasant sites. SAUSD will provide two school sites that offer sufficient amount of classrooms, conference rooms, meeting rooms, ceremonial spaces, and wireless internet. School Security will be provided throughout the tournament.

Both sites are conveniently located within walking distance of Downtown Santa Ana that offers an abundance of eateries, retail stores, lively culture and amazing art galleries. Hotels and motels are a 10-15 minute-drive from the tournament sites, making it particularly easy for participants to come and go from hotel to tournament site.

Specifically, Santa Ana High School will serve as the main tournament site, located at 520 W. Walnut Street, Santa Ana, CA 92701. About 50 feet across the way from Santa Ana High School is Martin R. Heninger K-8 School that will serve as the secondary tournament site, located at 417 W. Walnut Street, Santa Ana, CA 92701.

Main Site - Santa Ana High School



Santa Ana High School, 520 W. Walnut Street, Santa Ana, CA 92701, will serve as the main tournament site. The following list identifies the designated classroom and facility space that will be made available for NFA's use throughout the tournament timeframe. Santa Ana High School has wireless internet available throughout the entire campus.

Secondary Site – Martin R. Heninger K-8 School



Heninger Elementary School will serve as the secondary site for the NFA tournament 2019. This site also has wireless internet connection throughout the campus. The following list identifies the designated classroom and facility space that will be made available for NFA.

- ❖ Classrooms - 34 Classrooms available with occupancy of 30-40
- ❖ Laboratory Classroom with occupancy of 30-40
 - 8-10 tables
 - 35 chairs
- ❖ Multipurpose Room with occupancy of 150
 - Small stage
 - Stage lights
 - Small backstage
- ❖ Front Office with occupancy of 20
 - Copy machines
 - Computers
 - Printers
- ❖ Adult Transition Room with occupancy of 100
 - This area is split into 3 separate rooms with occupancy of 20, 30, 50
- ❖ Music Room with occupancy of 50
 - Two restrooms available within the room
- ❖ Library with occupancy of 40 standing
 - 2-3 tables and 10 chairs

Extemp Prep

- ❖ Santa Ana High School will provide sufficient space in the Small Gym that has an occupancy of 400+ and will designate the Large Gym available (occupancy of 1200+) for the use of the Extemp Prep. Either facility easily accommodates 175-200 extempers with plenty of room for tables/chairs and has adequate number of electrical outlets, as well as wireless internet.

Elimination Rounds

- ❖ Santa Ana High School will provide 20-30 classrooms with occupancy of 30-40 for the Elimination Rounds in addition to the following facility space at Santa Ana High School that can accommodate larger size groups (audience members): Band Room, Choir Room, Dance Room, Library, Counseling Office, Small Auditorium, Large Auditorium, and access to video equipment.
- ❖ Heninger School can also provide larger facility space for Elimination Rounds, which includes: Multipurpose Room and/or Library.

Tab Rooms

- ❖ Santa Ana High School's entire Front Office will serve as the Tab room, which has an occupancy of 20 with access to computers, printers, and copy machines. This area is conveniently located in the front of Santa Ana High School and within a close proximity of the Judges Room and the Ballot/Stuffing Area that will be stationed at Heninger School's site.

Ballot Pick-Up Area and Ballot/Stuffing Area

- ❖ The Ballot Pick-Up Area and Ballot/Stuffing Area will be conveniently located at Heninger School's Adult Transition Room, which is very close to the Judges Room. The Adult Transition space is split into three different rooms that can accommodate about 100 people and has tables/chairs available. There are also restrooms available inside the Music Room within the Adult Transition Room.

Opening/Closing Assembly

- ❖ Santa Ana High School's Large Auditorium will serve as the Opening/Closing Assembly facility, which has the capacity of 1200-1300 with a balcony, professional stage lights, video equipment (6 video cameras, 10 wireless/wired microphones, projector equipment and large screen, an orchestra pit, and ample size backstage).

Meeting Rooms

- ❖ Santa Ana High School's Counseling Center will serve as the space for meeting rooms as well as the Multipurpose Room and Library at Heninger School.

STAFF/EQUIPMENT/SERVICES

Computers

Santa Ana High School and Heninger Elementary School will provide access to 40-60 computers, 3-5 copy machines, 3-5 printers, and wireless internet at both sites. 10 laptops may also be made available upon request.

Ballot/Stuffing Staff

Santa Ana Unified School District's Speech & Debate Program staff and six Walk-On Coaches and 20 volunteers will be available to assist NFA with 3,000+ ballot packets and 500 ballots for L/D. Ballot Stuffing will take place inside the Adult Transition Room at Heninger School, which has occupancy of 100 people and the space is separated into three separate rooms.

Judges

The Santa Ana Unified School District's Speech & Debate Program will be able to secure 30-40 equivalent full-time judges, which will be compensated \$12 per hour from NFA and an additional compensation on Saturday and Sunday from the SAUSD's Speech & Debate Program. Judges will be able to meet in the Teacher's Lounge at Santa Ana High School throughout the tournament.

Printing

Access to several printers and copy machines will be made available at both tournament sites, specifically in the Front Office of both schools.

Video Equipment

The Santa Ana Unified School District can provide access to at least six video cameras (3 video cameras from Santa Ana High School and 3 other cameras from the SAUSD) and 10 external microphones for the recording of the Lincoln-Douglas final rounds.

Food Service

The City of Santa Ana is known for savory food options. The eatery choices in the city range from many styles and fusions to authentic foods from many international origins. The City of Santa Ana will be coordinating an amazing line-up of authentic gourmet mobile vending food trucks to be present at the school sites each day. Gourmet mobile food trucks are not only, delicious; they are also reasonably priced for college students. The tournament sites are within walking distance from Santa Ana's Downtown, which has an extensive number of eateries that are not only appetizing, but also provide a divine experience. Below is a small list of restaurants in Downtown Santa Ana. Lastly, SAUSD will set-up concession stands at both tournament sites for light snacks and beverages for purchase.

DOWNTOWN POSTING PARTY



Downtown Santa Ana has an astounding artist village with delightful energy, award-winning restaurants, and beautiful promenades surrounded by over 100 eclectic historic buildings. With its charming streets and vibrant restaurants, Downtown Santa Ana continues to be regarded as one of Orange County's best neighborhoods and was recently named one of the "Great Places in America" by the American Planning Association. The culture and flair of Downtown

Santa Ana offers a distinctive experience in Southern California. The neighborhood is filled with eclectic restaurants, one-of-a-kind retail shops, independent breweries, weekly pop-up markets, community-driven chef incubator spaces, creative office space, live-work housing, government offices, art studios, North America's first E-sport Arena, Orange County's only independent art house cinema, and a university-run art residency complex hosting internationally renowned and emerging local artists. With its bustling nightlife and new residential scene, the Downtown has become a hot spot for visitors, tourists and residents to get that fresh, new and exciting experience.



Santa Ana's Downtown is the perfect combination of historic and hipster culture providing an exceptional outdoor venue for the Student Party. Downtown Santa Ana is known for hosting outdoor events, which occur at least twice a month and a few large festivals throughout the year that attract over 25,000 people per event.

The Student Party would take place in a four block parameter in Downtown Santa Ana that would include the lot on 3rd Street & Bush, as well as the Spurgeon Promenade and Second Street Promenade. Downtown Santa Ana business associations have agreed to assist in the coordination of a downtown tasting event in which many of the downtown restaurants open their doors and provide delicious samples of their food. Participants will have to opportunity to enjoy this unique tasting event along with live music and street performers. The City of Santa Ana will coordinate the party logistics, engage the downtown food and retail businesses to offer low-cost food samples, and will provide a one-of-a-kind unique outdoor experience that your students and their families will remember for a lifetime.

The Santa Ana Unified School District will support onsite participant food discounts, arrange for local music & entertainment, set-up a professional grade outdoor movie theatre system, and cover the cost of street closures and police officer enforcement. Music, food, and entertainment will ensure a phenomenal experience for the NFA participants, coaches, and administration.

MOTEL/HOTEL ACCOMODATIONS

California is a dream destination, particularly the City of Santa Ana. Hosting the NFA Tournament in Santa Ana would grant the attendees' biggest wish of visiting the Golden State of California - become a reality. April is a perfect time to visit California because of its amazing weather, outstanding attractions, and accessibility to the beach, mountains and so much more – all within 15-20 minute drive. The City of Santa Ana is committed to continuing negotiations with all the hotels/motels listed below and leveraging funds/resources to assist in reducing the cost of room reservations in order to reduce the cost for the tournament participants. The Santa Ana Chamber of Commerce, who have several current hotels/motels as members, are committed to assisting in the negotiation of hotel room rates for this tournament.

NFA will have many options with regard to available hotels/motels, which are mostly located in Santa Ana, but could extend the options to span into a few neighboring cities such as Costa Mesa, Anaheim, and Irvine. The neighboring cities are between 10-20 minutes from the competition school sites and within close proximity of freeways. In general, the room rates range from \$109-~~\$222~~ with hundreds of rooms available in the inventory provided below.



The DoubleTree by Hilton Santa Ana Airport Orange County would like to be the host hotel for the 2019 NFA Tournament. Furthermore, the DoubleTree by Hilton Santa Ana would be happy to block 100 guest rooms at a rate of \$149 per night for

tournament participants. The hotel is one of the largest and newest hotels in the city with a great amenities such as: several meeting rooms with occupancy 15 each, ballroom space with occupancy of 500+, business center, free shuttle service to/from John Wayne Airport, breakfast service, and free Wi-Fi. Additional negotiations about room rate and comped rooms for NFA staff can be arranged for future discussion with the DoubleTree by Hilton Santa Ana, NFA and the Santa Ana Chamber of Commerce.

The Santa Ana Chamber of Commerce has also secured a proposal from several hotel/motels who have pledged a number of room blocks at reasonable room rates. The Holiday Inn Santa Ana Orange County Airport has pledged to block 75 guest rooms at a rate of \$109 per night (single – quad occupancy) with complimentary breakfast buffet (up to 4 per room), free Wi-Fi, and free parking. Holiday Inn may serve as an alternate or secondary host hotel if desired by NFA.

The table below provides a list of hotels/motels near the tournament sites that will surpass the required minimum of 250 rooms needed for the NFA 2019 Tournament. Several include breakfast and the Santa Ana Chamber of Commerce will continue to negotiate additional amenities.

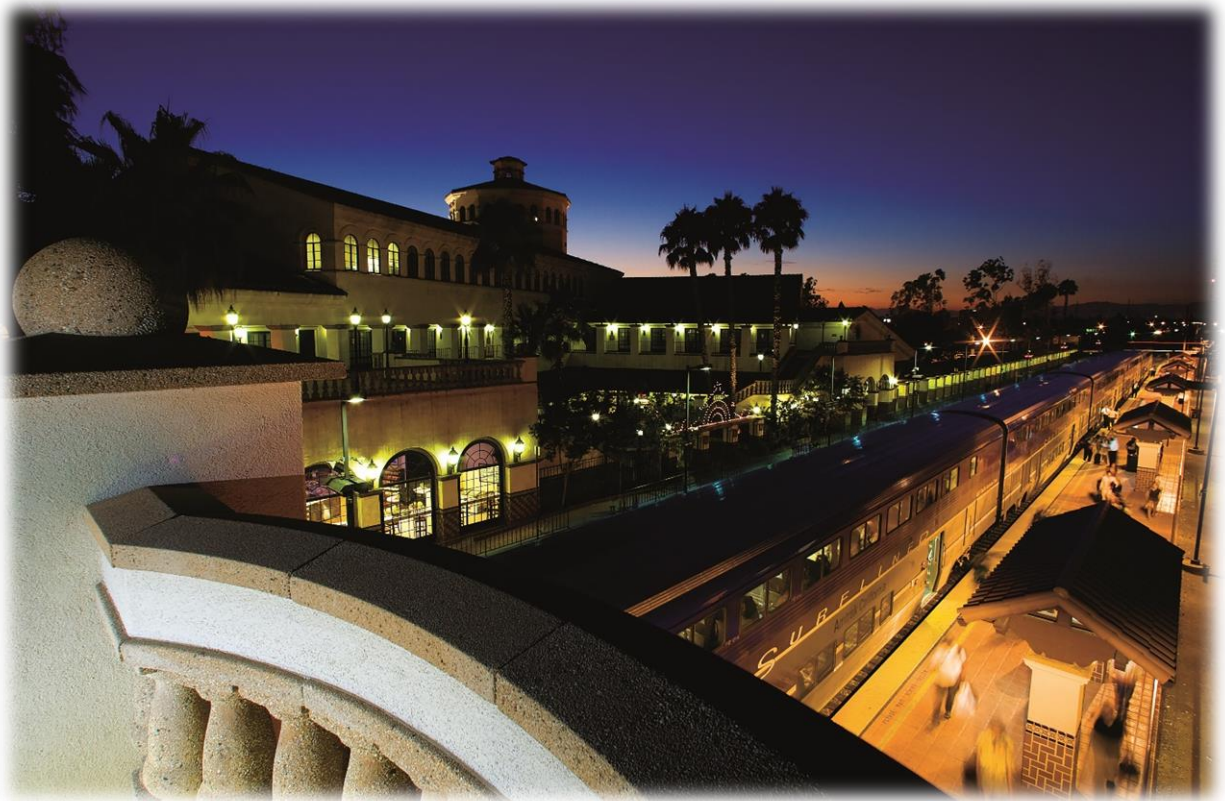


CONCLUSION

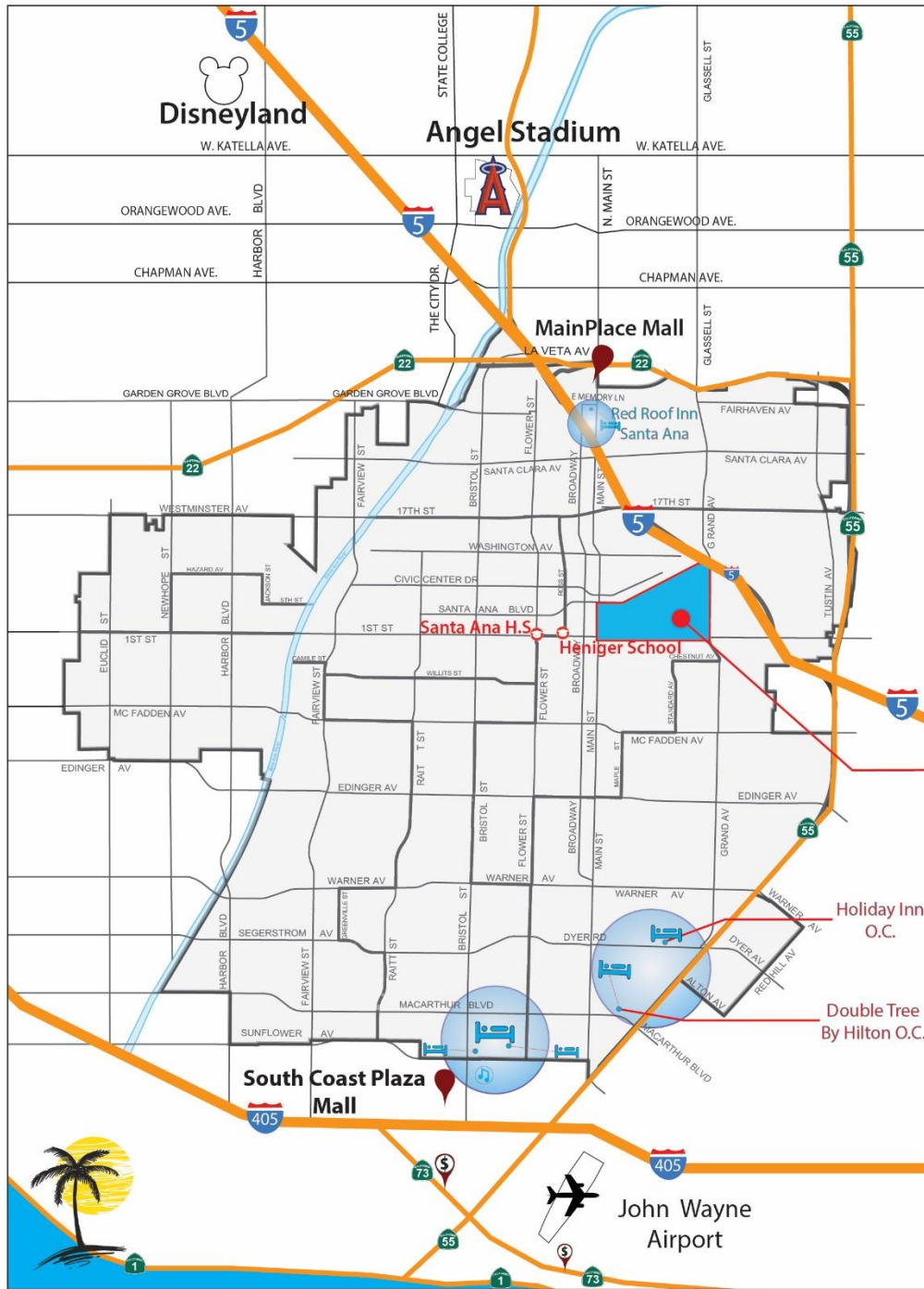
